Introducing the Mt. Adams Prescribed Burn Association (MAPBA)

In the dry, fire-adapted forests of the Mt. Adams region, "fighting fire with fire" is actually an efficient and essential strategy for reducing wildfire risk to communities like Trout Lake. For a primer on **prescribed fire** (the planned, skilled application of fire to a landscape to meet certain management objectives), check out our newsletter from earlier this year.

While state and federal agencies in the West have made headway in treating public lands with prescribed fire, there is still substantial need to increase the pace and scale of prescribed fire on privately-owned land. About 3.2 million acres of forestland in Washington State are managed by small forest landowners, and these acres are often located within or adjacent to communities where wildfire damage potential is high. Treating these lands with prescribed fire can restore ecological health and reduce fuel loading that otherwise increases the risk of catastrophic wildfire.

As you might imagine, the skills, equipment, and other resources needed to use prescribed fire at scale are not always easily available to small private landowners. Enter: the Mt. Adams Prescribed Burn Association. The MAPBA is a new grassroots coalition of private landowners, non-governmental

organizations (e.g., land trusts, nonprofits), and community members that promotes collaboration and resource sharing to safely accomplish prescribed burning. Roles and services of MAPBA include:

- Connecting local land managers with crews/volunteers to staff prescribed burn projects;
- Hosting prescribed fire trainings;
- Managing a shared equipment cache; and
- Assistance with burn plan writing.
